PLANT OVERVIEW:

LANPL having its corporate office at Lanco House, Plot # 397, Udyog Vihar, Phase-3, Gurgaon-122016 New Delhi Region, India operates 1200 MW (2 x 600 MW) power plant at Village-Anpara in Sonebhadra District of Uttar Pradesh, India. The plant has its own Railway Siding having Alpha Code – LAKS.

1.0 INTRODUCTION

LANPL intends to procure 4 Lac MT (- 5%) of imported coal on 'FOR Destination' for its thermal power station located at Anpara, Uttar Pradesh. Bidders must offer to supply a minimum quantity of 1 lac MT to be eligible under this tender document.

The scope of work broadly includes import of coal at Indian Ports, stevedoring, handling, storage, port clearances, arranging Railway rakes, loading, transportation and delivery at LANPL power station. All other activities for clearing and forwarding of the consignments like customs clearance, coordination with Port, Railways and any statutory authorities shall also be part of scope of work. Unloading of coal at Power Station end from Railway wagons shall be arranged by LANPL.

The coal shall be procured by LANPL on plant delivered basis and the bidders shall have to carry out handling of cargo till final delivery at the power station of LANPL. Bidders are required to submit their price quotes accordingly.

Sealed tenders are invited from competent bidders in the two stage bid system under this tender and terms thereof.

2.0 BID QUALIFICATION REQUIREMENTS

- a) The Bidder should have supplied at least one (01) Lac MT of imported coal, on FOR Destination basis to industrial utility directly or through PSU, during any of the last three (3) Financial Years i.e. FY 2012-13 to FY 2014-15.
- b) The Bidder should have annual turnover of more than INR 300 Cr. in any of the three (3)
 Financial Years FY 2011-12 to FY 2013-14.

3.0 COST OF BIDDING

The Bidder shall bear all costs associated with the preparation and submission of Bid and LANPL will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the Bidding Process.

4.0 TENDER DOCUMENT
