2.1) Excavation of Ash from LAPL Ash Pond/Dyke

- a) Based on SECL's requirement of Ash, bidder must submit excavation plan to EIC LAPL.
- b) The bidder shall excavate the ash from the ash ponds by mechanical means such as excavators. The Bidder shall excavate ash to the required depths and inclinations leaving the excavated surface level and trim as per the direction of the Engineer-in-Charge. Bidder shall take all the necessary precautions at his own cost to avoid slipping off from sides.
- c) Required necessary industrial standard de-watering pumps, pipes and ancillaries like cable board with RCB for ash de-watering nearby location as required as per the instructions of EIC is in Bidder's scope.
- d) Temporary electric connection on north side of ash pond will be provided by LAPL and necessary industrial standard cable, lights, boards, switches, RCB, laying and maintenance of equipment is in the scope of Bidder.

2.3) Transportation of Ash

Nuisance free and pollution free transportation should be the main conditions of transportation of ash in leak proof covered dumpers up to the dumping area as per MOEF&CC, RO CECB-Korba and SECL's guidelines.

- a) Transported ash in the dumpers should be disposed at the approved site as instructed by Sub Area Manager/Sub Area Manager (Manikpur Mines) of SECL. All necessary precautions must be taken to avoid pollution due to disposal of ash.
- b) The charges of fuel, machine maintenance, oils, operator, and helper charges are in the scope of bidder.
- c) Machine marching is in the scope of Bidder, no other charges will be paid for any transportation, machine movement after closing of daily work. All transportation of machines & tools, marching is in the scope of Bidder.
- d) The empty and loaded dumpers should follow the route as directed by the LAPL Engineer-in-Charge (EIC) i.e. HOD, Civil Department.
- e) The route for transportation of ash to various locations should be finalized in consultation with Sub Area Manager, Manikpur mines, SECL.
- f) The body of the vehicles engaged for transportation shall be perfectly leak proof. Back door of the dumpers should be perfectly closed without any gap, to avoid any spillage during transportation of ash.
- g) There will be no consideration for idle and escalation charges during the contract period except diesel price variation clause as defined in tender documents. **Refer point no. 10(g)**
- h) Top covering of vehicles with tarpaulin during transportation and to ensure no leakage/no spillage of ash is in the scope of Bidder to prevent emission of ash during transportation.
- i) For any environmental impact against MOEFF&CC guidelines, the Bidder will be responsible and attend to the same at their own cost. The Bidder will be responsible for any adverse environmental impact due to dumping of the fly/pond ash. - s) Safety & others sign boards should be placed at dyke and on the route of the transportation inside LAPL or as per instruction of EIC.
- t) Bidders have to coordinate with Korba district Administration, SECL, LAPL administration for transportation of ash and they have to follow their directives issued from time to time.
- u) Transporters should display **Toll Free no** for ash transportation issued by Collector office Korba in every ash transporting trucks.
- v) Format issued by RO CECB office, Korba for ash transportation details should be present in every ash transporting vehicles.

2.4) Weighment

LAPL is having RFID enabled weighbridge. "Single Tare weight" will be done for a truck for a day in its first trip and for subsequent trips on the same day, only gross weighments will be done. The following guidelines to be followed by the bidders:-

- a) Both, Tare and Gross weighment of trucks to be done at LAPL weighbridge. Weighment at LAPL Weigh Bridge shall be considered as final and binding.
- b) In case of Weighbridge shut down/maintenance, designed capacity weight of vehicle will be given if truck filled full & Tare weight of the vehicle will be considered as per the previous records.

including the supervisor(s) for the said work shall be provided to the Engineer-in-charge and prior permission shall be obtained from Engineer In charge in this regard. The agency shall be responsible for initial medical examination, vocational training, valid driving license, issuing i-card of the manpower engaged by them for the work etc.

- f. In case of any accident arising in the course of execution of the agreement and/or arising out of non-compliance of any of the conditions of this agreement or due to any deviation from the SOP, the bidder (transporter) shall be solely responsible for any consequences that shall follow.
- g. The bidder (transporter) shall familiarize themselves with and be governed by all laws and rules of India and local statutes and orders and regulations applicable to his/their work.

- I. The total available space shall be filled/utilized till its completion, thereby total Ash transportation qty. shall be decrease depending upon the space availability in the Manikpur mines and SECL instruction
- m. Only tipping trucks/dumpers with mechanical/automatic unloading arrangements shall be deployed by the agency and in no case "Dala trucks/vehicles" shall be deployed or permitted to be deployed for the work.
- n. Safety features to be incorporated in Tippers/Trucks will be a part of the agreement and bidder (transporter) shall ensure to implement the same as per the list of safety features provided by the DGMS list enclosed in Annexure III
- o. Only equipment as elaborated above, in good and safe condition having valid fitness certificate permits/licenses etc. (wherever applicable) and in respect of which the required taxes/fees have been deposited and which are properly covered by insurance, shall be deployed for the work.
- p. Only experienced, skilled and disciplined operators/drivers of sound health, good behavior and antecedents having valid and requisite driving/statutory license shall be deployed by the Agency for the work. - t. Agency's (bidder's) dumpers/tipping trucks should ply on specified routes/roads inside the mine. In case, plying on any other route becomes necessary, due to any reason, prior approval for the same shall be taken by the agency from the Engineer-in-charge (Area manager/Sub Area Manager, Manikpur, SECL).
- u. The work shall be executed in such shift(s) or during such specified period on all days of the week as directed by the project officer/Engineer-in-Charge (Area manager/Sub Area Manager, Manikpur, SECL) and the ash transporting contractor shall be obliged to comply with the same.
- v. Attested photocopy of valid driving license/Vocational training certificate issued by the vocational training center of SECL of all the drivers/operators engaged in the work shall be deposited with the company.
- w. The contract of ash transportation would be terminated or suspended by SECL, in case the above said terms and conditions are not satisfied/ are being violated, by giving one month's show cause notice, as required. - h) The Bidder shall not resale the ash lifted from LAPL or indulges in any profit making venture from the same and dispose of ash as per agreed terms.
- i) The Bidder shall be fully responsible for the operation of the machinery. For any incident due to mishandling or faulty operation of the Bidder/Bidder's workers, such Bidder will be fully responsible.
- j) Ensure that the vehicles which will be entering the plant should have proper gate pass and staff should carry valid gate passes.
- k) Work will be carried out as per mutually agreed SOP/Work Order.
- One dedicated supervisor and two signalmen should be deployed on each shift at loading point to instruct the movement of vehicles during loading and unloading area one supervisor and signal man.

- c) Penalty will be levied if any LAPL property is found damaged during the ash disposal.
- d) Penalty will be levied in case of any safety violations during the ash disposal as per the LAPL Safety norms and penalty amount shall be deducted from bills.
- e) Penalty will be levied in case of any Environment violations during the ash disposal as per the LAPL Environment norms and penalty amount shall be deducted from bills.

4) Special terms and conditions:-

Mobilization of manpower, material, tools and machinery shall be done within 10 days from the date of issuance of PO/LOA or date of intimation of site clearance by LAPL EIC. In case there is delay in issuance of gate pass by LAPL due to non-provision of required documents as per the process, the same shall be in Bidder's account. Annexure-VII

SOP for Dumper operator

Do's-

- 1. Before starting engine, ensure adequate level of engine oil, radiator water, tyre air pressure of the vehicle.
- 2. Before starting machine check air pressure, emergency brake, horn and magnitude of brakes.
- 3. While operating check engine oil level gauge, pressure gauge, water temp. gauge, ampere meter, transmission oil temp. gauge and other indicators lamp.
- 4. Operator needs to check oil leakage from the engine whenever operator comes out of the machine for any work (especially over the turbocharger, as there is a chance of fire if continuous oil leaks over the turbocharger).
- 5. Remove oil, grease, coal dust from Electrical appliances/ wires
- 6. Use dipper when vehicle is coming from the opposite direction in night.
- 7. Always keep speed of the vehicle under control and within limits inside the mine area.
- 8. Keep the dumper away from the edge while dumping in the dumping area.
- 9. Don't park the vehicle in the slope. If require to park the vehicle in slope, use stopper in the tyres.
- 10. Always drive within the speed limits with minimum use of brake.
- 11. Ensure that nobody is working in the dumper before starting the dumper.
- 12. Thoroughly inspect the dumpers.
- 13. Inspect beforehand of any obstacle before displacing the dumper.
- 14. Give horn two times for moving the dumper in forward direction and three times for moving in reverse direction.
- 15. In steep slope and turn, slowdown the vehicle speed and keep the vehicle in safe side while using horn and light.
- 16. Keep the vehicle in lower gears in downhill slope and use retarders if require.
- 17. Strictly follow traffic rules and signboards.
- 18. After dumping move vehicle only when the raised part sets down.
- 19. Wherever road partition is not present, keep the vehicle in safe side and give side to vehicle coming from opposite direction.
- 20. While parking the dumper, put gear to neutral, engage hand brake and use stopper in tyres.
- 21. Always check gauges and warning signs.
- 22. Ensure fire extinguisher is available in the vehicle.

Don'ts

- 1. Don't lift anyone in the dumper. Use of mobile and earphone is prohibited while driving.
- 2. Don't overtake the dumpers moving forward.
- 3. If there is doubt in brake and steering system of the vehicle then rectify it before starting the vehicle.
- 4. If water temp reaches 91 degree or more, don't run the machine.
- 5. Use minimum use of retarder brake, as it heats transmission oil.
- 6. Don't press starter key for more than 30 seconds at one time. And for long cranking give interval of 2 to 5 minutes between two long starter push.
- 7. Don't use emergency steering switch for more than 30 seconds at one time.

- 8. After starting machine, don't race engine till the engine oil pressure do not comes to normal.
- 9. Don't run engine idle for more than 5 minutes.
- 10. Don't stop the engine without idling it for at least 3 minutes.
- 11. Use parking brakes only while parking the vehicle and in emergency.
- 12. Don't stop the machine at gear-engaged position.
- 13. Don't park the machine at unsafe place.
- 14. Don't allow anyone to step in or step out from the machine when it is running.
- 15. Don't allow anyone except maintenance staff to touch the machine.
- 16. Maintain a distance of 50 feet from the running vehicle at the front and 100 feet while moving in downward slope.
- 17. In any indispensible situation follow the instruction of site supervisor.

Traffic rules and procedures to be followed at SECL premises

Rule 1 (Procedure)

- 1. Any unauthorized person can't run the vehicle inside the mines.
- 2. When any work is going on the vehicle by fitter or trial is being taken, then authorized driver will only run the vehicle.
- 3. While driving the vehicle, driver always need to keep Driving license and Mines Training certificate with him.

Rule 2 (Speed limit)

- 1. Permanent or temporary speed limit as decided by the mines manager for a vehicle or for any particular area will be applicable.
- 2. Wherever condition of roads is not good or visibility is less, vehicle driver has to decrease speed in order to ensure control in the vehicle.

Rule 3 (Preference)

- 1. If traffic is not controlled by traffic signs in places where two roads meet, driver must follow the below procedure.
- 2. Every vehicle should provide way for vehicles with Red lights.
- 3. Light motor vehicle will always give way to heavy vehicles.
- 4. No vehicle driver should try to overtake the other moving vehicle, it can lead to collision.

Rule 4 (Parking of the vehicle)

- 1. Vehicle driver should not park the vehicle in such a way that it creates difficulty in smooth movement of traffic.
- 2. Vehicle driver should always park the vehicle in authorized designated place as decided by the mines manager. If any vehicle is in breakdown condition, then always engage the parking brake and put stoppers in all the tyres, always keep ON the parking light of the vehicle in night. Keep stones around the breakdown vehicle so that other vehicle drivers get to know about the breakdown condition of the vehicle.
- 3. Every vehicle drivers before leaving the vehicle will ensure the safe condition of the vehicle such as parking brake engaged or not, parking is systematic and 10 meters space is given between the two vehicles at parking place.

- 4. Never park the vehicle in downward slope (in ramp). If vehicle is breakdown in the slope, put stopper in all the four wheels and ensure that stopper do not breaks due to the load of the vehicle. Whenever vehicle gets breakdown in such a condition, immediately inform to higher authority.
- 5. Never stop the vehicle in the ramp, and don't allow anyone to step in into the vehicle.

Rule 5 (General)

- 1. In vehicle which is being towed or which is hampering the traffic, use emergency light, both in front and back of the vehicle. Use strong iron rods for towing purpose of the vehicle.
- 2. Operator or vehicle driver will be responsible for cleanliness, adequate engine oil, water level, engine condition of the vehicle or other machines which are available.
- 3. Use of dipper headlight is mandatory in traffic area and in mobile workplace.
- 4. Vehicles which are running in the road/earth will always use horn before moving and vehicle driver will ensure that nobody is present around the vehicle by checking all the sides of vehicle, under the vehicle.
- 5. Vehicle driver should get satisfied themselves with their driving skills and vehicle performance before parking/reversing the vehicle, to give pass to other vehicle, to cross any stationary vehicle.
- 6. Don't run light vehicles in the road of heavy vehicles, use high indicator in light vehicles if it is running in roads of heavy vehicles.

Rule 6 (Overtaking)

Whenever vehicle driver needs to overtake other vehicles then they should abide by the following rules (the best is to not to overtake)

- 1. Never increase the speed.
- 2. Overtake the vehicle only when the view of the road is clear beyond the vehicle which is being overtaken.
- 3. While overtaking mind the inter section and junction of the road.
- 4. Overtake only when green flash/light is given from the vehicle which is being overtaken.
- 5. Vehicle driver who is running heavy vehicle will not overtake other vehicles in the downward slope unless the speed of the vehicle which is being overtaken is less than 10 km/hr. and view of the road is very clear.
- 6. If route divider/road diversion is near, overtaking is not allowed.

Rule 7 (indications/directions):

- 1. Always follow all road signals. If any doubt regarding meaning of the signal, contact with the supervisor.
- 2. Always keep in mind warning indications and instructions of daily blasting.
- 3. Remove temporary indications/signals immediately after its purpose is served.

Rule 8 (Engineering conditions of the vehicle)

- 1. Every vehicle driver should get satisfied himself thoroughly about the safe and perfect working of the vehicle, by checking it daily.
- 2. Every vehicle driver needs to report to its supervisor if any problem found in the vehicle, if any injury occurs to someone on the vehicle/due to the vehicle or any incident/accident happens with the vehicle.
